2022 License Renewals Start July 1!

The annual licensure renewal period is July 1 through September 30. You must complete your online renewal application **by midnight on September 30** to avoid the expiration of your license.

Renewal fees are the same this year- \$130.00 for PTs and \$93.00 for PTAs (plus a processing fee). To renew your license, go to our website, www.pt.alabama.gov, and select the "Licensing Renewal" tab. Once there, scroll to the bottom of the page and select "Renew Your License Here." You will be prompted to select your license type, license number, and last four digits of your social security number. Once entered correctly, your profile should appear and you may begin updating and entering information.

All licensees are required to upload their continuing education certificates, preferably in pdf format. There will be three options to choose from when you are renewing your license:

1. I graduated in the last calendar year and I am renewing for the first time. You will be required to upload 2 hours of Alabama Jurisprudence.
2. I am renewing my license for the first time in Alabama. (I am not a new graduate). You will be required to upload 8 hours of CE and 2 hours of Alabama Jurisprudence.
3. This is not my first license renewal in Alabama. You will be required to upload 10 hours of CE. (No Alabama Jurisprudence Required).

You can proceed with renewing your license online once you upload the required documents. We hope to have the "bugs" worked out from last year that prevented renewals from mobile devices and tablets. However, if you experience issues while trying to renew, we recommend trying from a desktop or laptop computer.

REMINDER! The ABPT **does not mail certificates each year when you renew!** If you wish to have an updated certificate with the gold seal, there is a \$5.00 fee. Please keep a copy of your receipt for your records. The email with your renewal verification will come from an email address that contains "igovsolutions". Please check your spam/junk folders if you do not receive it in your regular inbox. All licensees are encouraged to visit our website and create a licensee profile under the "Services" tab, if you have not already done so. You are able to access and print your license and your receipt throughout the year. See page 3 for additional instructions.

We strongly encourage you to renew early to avoid any potential issues!

Update on Alabama as Compact Privilege State

Many have asked the status Alabama's ability to issue "Compact privileges." Alabama is not able to issue or accept Compact Privileges yet. As you may recall from our Spring 2021 newsletter, Governor Ivey signed legislation making Alabama the 31st state to join the PT Compact on March 18, 2021. Our neighbor states Mississippi, Tennessee, and Georgia are actively issuing and accepting Compact privileges. Please refer to <http://ptcompact.org/ptc-states> for an interactive map showing all states in the PT Compact, including those who are issuing compact privileges.

As a reminder, initial PT Compact bill was introduced in the 2020 legislative session, but did not progress due to the COVID-19 public health emergency. Senator Whatley, the Senate sponsor, reintroduced the bill in the 2021 legislative session, with the House companion bill sponsored by Representative Parker Moore. The bill quickly gained traction because it was one of a package of bills that the Military Stability Commission put together in an effort to make Alabama friendlier to military service members. The Commission was chaired by Lt. Governor Will Ainsworth and included a number of bills to provide for the acceptance of occupational licenses from other state boards for spouses and dependents of military members.

However, Alabama cannot begin issuing Compact privileges until there are other significant changes made to the Alabama Physical Therapy Practice Act (APTPA) and the Administrative Code to include Compact privileges. The Board has written a bill which will address all of the necessary changes to the APTPA, however, the bill was not proposed before the end of the 2022 legislative session. The Board will be working diligently to move the bill forward during the 2023 legislative session.

The Board anticipates that it could be ready to issue Compact privileges within the next two years. We will provide regular updates on our progress through social media and on our website. Of course, licensees are welcome to attend board meetings at any time. Wellness Program

The Alabama Board of Physical Therapy continues to work with Dr. Michael Garver, DMD, to provide an Impaired Practitioner Wellness Program as a service to licensees in the State of Alabama. This program is designed to help licensees that are impaired by reason of illness, inebriation, excessive use of drugs, alcohol, narcotics, chemicals or other substances, or a result of a physical or mental condition. Currently the program has 16 participants, with 15 of those entering the program by self-report. This self-reporting option provides the opportunity for a licensee to directly contact Dr. Garver and receive much needed help without jeopardizing their license. Self-reporting avoids a formal ABPT hearing, and the subsequent reporting to the National Practitioner Data Bank. Additionally, there is no public record as participants are only known to the ABPT by case number. For assistance, physical therapist and physical therapist assistants may contact the executive director at 1-855-865-6704 (Wellness Center Hotline) or may contact Dr. Garver directly at the information below.

Mentors continue to be fundamental in the success of the program. They allow participants to have someone to turn to that have faced those same challenges of addiction. Mentors remain anonymous and time frame for participation is at each individual's discretion. If you are interested in becoming a mentor, please contact Dr. Garver at the contact below.

BOARD NOMINATIONS

Members of the Alabama Board of Physical Therapy are appointed for staggered terms of five years each, so that at least one member's term expires each year. Members of the Board are appointed by the Governor from a list of five persons nominated for each place on the Board by the current licensees and certified to him or her by the Board.

Position coming available this year: one PT position currently held by Alina Adams, representing Congressional District 4.

The Board is accepting nominations of **currently licensed physical therapists who reside in districts 2, 3, 4 or 7** to fill the vacant position. See next page a map showing the district locations.

Nominations, which must include a written, signed consent-to-serve letter from each nominee, may be submitted via mail, fax, or email to the Board's office, **but must be received** no later than end of business on July 29th, 2022. In the event five qualified nominations from the above listed Congressional Districts are not received prior to the July 29th, 2022 deadline the Board will request qualified nominations during the Board's meeting on August 6th, 2022. Any person nominated from the floor must provide the Board with a written, signed consent-to-serve letter within 30 days (that is, end of business on September 7th, 2022) or be present to provide the consent-to-serve verbally. In the event five qualified nominations from the above listed Congressional Districts are not received, nominations will be accepted from the state-at-large during the Board's meeting on August 6th, 2022.

Qualifications for nominees for the position are:

- (1) Be a resident and citizen of this state.
- (2) Have practiced physical therapy within the State of Alabama for the three years preceding his or her appointment.
- (3) Shall have no disciplinary action against their license for the three years preceding his or her appointment.
- (4) Must provide written, signed consent to serve.

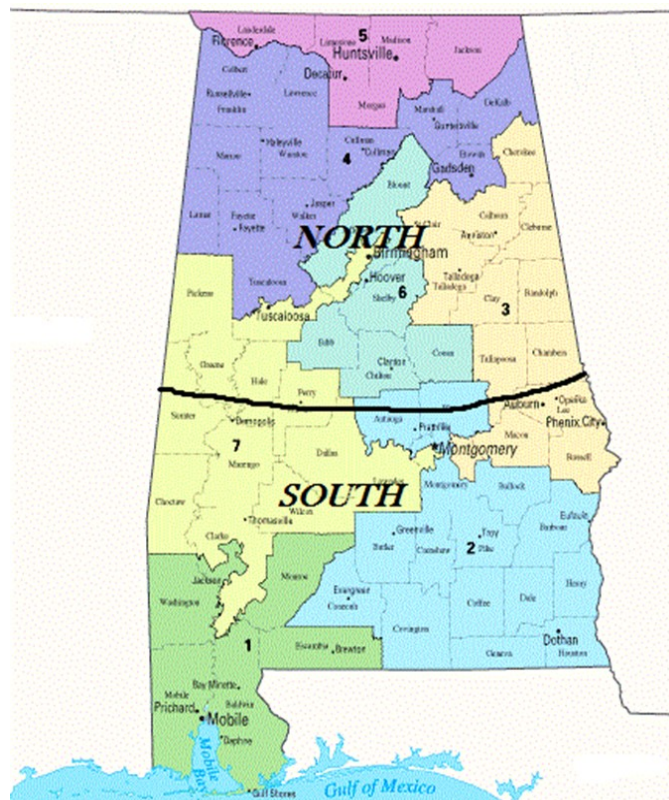

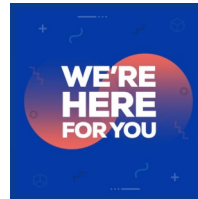
