Licenses expired for less than 5 years are eligible for renewal and restoration. To renew your license, return this form with:

1. Certificates of completion of CE (10 hours per year expired)
2. A clear, legible copy of your valid, unexpired government issued ID (driver's license, passport, etc.)
3. A copy of proof of legal presence in the United States (birth certificate, US passport, proper immigration documents, etc.)
4. Appropriate renewal fee of \$230 PT or \$193 PTA plus a \$50 restoration fee (total of \$280 for PT and \$243 for PTA). Payment must be in a form of cashier's check or money order made payable to the Alabama Board of Physical Therapy.

Practicing without a license is a Class C misdemeanor punishable by a fine of not more than \$500, or by a term of imprisonment of not more than 90 days, or both. *ALA. CODE Section 34-24-196 (1975)*
